

SECTION 245

SPECIAL DISTRICT 215 (SP.215)

245.1 For the purpose of this by-law, land use district "Special District 215" is hereby established and may be referred to by the symbol "SP.215".

- (i) a beer, wine or liquor store a studio or craft workshop (j)
- (k) a library, museum or art gallery
- (1) a restaurant
- (m) a service station
- a retail establishment including a convenience retail store, drug store or bakeshop (n) for the sale of:
 - i) food
 - optical supplies ii)
 - books, magazines and stationery iii)
 - iv) smoking supplies art supplies V)
 - floral and horticultural products vi)
 - photographic supplies vii)
 - viii) paint, wallpaper and decorating supplies
 - sporting goods (excluding boats, snowmobiles, motorcycles, motors) ix)
 - pharmaceuticals X)
 - xi) jewellery
 - radio, television, electrical and home appliances xii)
 - clothing, office supplies, home furnishings XIII)
 - hardware xiv)
- an establishment wherein any of the foregoing merchandise of Section (n) is rented (o) or repaired.
